Directions:

From the North: Take the Garden State Parkway south to Exit 145 (Oranges – Newark – Harrison). Follow signs to East Orange and Central Ave. Turn Right at Central Ave. and follow to South Arlington Ave. Turn right.

From the South: Take the Garden State Parkway north to Exit 145 (Oranges – Newark – Harrison). Follow signs to East Orange and Central Ave. Turn right on South Groove St. towards Central Ave. Turn right on Central Ave. and follow to South Arlington Ave. Turn right.

From the East: Take Route 280 East. Exit at the East Orange - Clinton exit. Stay to the left as you exit on Freeway Dr. West. At South Burnet St. (2nd traffic light), turn left. At the first traffic light, turn left onto Freeway Dr. East. Follow to South Arlington Ave. and turn right.

From the West: Take Route 280 West. Take Exit 11A to Freeway Dr. East. Stay to the right and **do not follow** signs back to Route 280. Turn right on South Arlington Ave.
